We would like a 10 day lead time on all wholesale orders, however most products will ship much earlier than that. All wholesale orders have a minimum order of \$150.00, so if you are on the wholesale side of the website, trying to place an order below this minimum you will get an error message stating you are under the minimum order amount and will have to either bring this up or be willing to pay at our regular site pricing where no minimum is required. Once your order has been placed, you will immediately receive a receipt for your records.
